1 INTRODUCTION AND APPOINTMENT

Jasminas Holdings Limited ("the company") was placed into liquidation by a special resolution of the shareholders pursuant to Section 241(2)(a) of the Companies Act 1993 ("the Act") on 28 July 2016. Peri Micaela Finnigan and Boris van Delden, CAANZ Accredited Insolvency Practitioners, were appointed as joint and several liquidators of the company.

2 RESTRICTIONS

In preparing this report and its appendices we have relied upon information provided to us. We have not independently verified or audited that information. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

The company operated as Jasminas Indian Cuisine until October 2013. Spot liquor commenced under the same company structure in November 2013. This business was sold in June 2016. The liquidation arises following cessation of trading.

5 STATEMENT OF AFFAIRS

A Statement of Affairs showing the company's estimated financial position as at the date of our appointment is provided at Appendix 1.

6 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

We will realise all available assets.

We will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for,
- determine if there are any other avenues of recovery for creditors,
- determine if the company's officers have properly carried out their duties, and take appropriate steps where necessary.

If there are funds available for distribution to creditors we will verify creditors' claims and make a distribution. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

7 LIABILITIES AND CREDITOR CLAIMS

7.1 Secured Creditors

At the date of liquidation two secured parties had registered security interests against the company on the Personal Property Securities Register, however, we understand from the directors that there are no funds owing to the secured creditors.

- Coca Cola Amatil (NZ) Limited
- Independent Liquor (NZ) Limited (note: this security has now been discharged).

Personal Property Securities Act / Reservation of Title

Should any creditor believe that they are entitled to any goods, or proceeds from realisation of goods, due to holding a Purchase Money Security Interest, they should contact us immediately.

If any creditor believes that they have a Reservation of Title over goods and they have not perfected their interest, they should also contact us immediately.

7.2 Preferential Creditors

We have been made aware that there may be a preferential claim from a former employee, however the claim is disputed. The liquidators will investigate the validity of this claim.

7.3 Unsecured Creditors

The company's accountant is unavailable until end of August 2016 to furnish company records. We are unable to estimate the amount due to unsecured creditors. We are advised the only creditor is the contingent employee claim. A schedule of known creditors and their addresses is provided at Appendix 2, as required by Section 255(2)(c) of the Act.

A notice to creditors to prove debts or claims is included at Appendix 4. Also enclosed is a creditor's claim form for completion and return to this office by Friday, 9 September 2016. Creditors that have not made a claim by the date on the notice may be excluded from any distribution made. If you believe that you are a secured creditor please contact us and the appropriate form will be sent to you.

8 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the Liquidators' decision to dispense with the meeting of creditors is provided at Appendix 3.

Pursuant to Section 314 of the Companies Act 1993, creditors are advised that at any time in the course of the liquidation the Liquidator shall, at the request in writing of any creditor or shareholder, call a meeting for the purpose of appointing a liquidation committee.

4. The equipment was returned and/or assigned at date of sale of business. The director advises there is no money owing under the registered security.
5. The assets of the company were sold to a new owner prior to liquidation. A loss was incurred by the shareholder on his original investment in the company. The proceeds of sale were attributed to costs of sale and the bank overdraft.

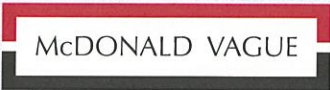
