## 1 INTRODUCTION AND APPOINTMENT

Peri Micaela Finnigan and Iain McLennan, Insolvency Practitioners, of Auckland, were appointed as joint and several liquidators of Real Fires Group Limited ("the company") on 8 August 2019. Peri Micaela Finnigan resigned from her position as liquidator on 26 June 2022, appointing Boris van Delden, Licensed Insolvency Practitioner of Auckland as her successor.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This seventh report should be read in conjunction with the liquidators' previous report. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

A Statement of Realisations and Distributions is not attached as there have been no realisations or distributions during the liquidation.

## 2 RESTRICTIONS

## 3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

### *Asset Realisations*

The company had no assets at the date of liquidation. There have been no realisations nor payments, therefore no Statement of Realisations and distributions is included in this report.

## 4 INVESTIGATIONS

The liquidators' investigations into the books, records and affairs of the company and related company are ongoing. Our investigations indicate that the company was incorporated as a vehicle for restructuring, which process was only partially completed and then abandoned. The affairs of the company are closely related to those of Real Fires (NZ) Limited (in liquidation), which was placed in liquidation on 5 August 2019, with Peri Finnigan and Iain McLennan appointed as joint and several liquidators. Peri Micaela Finnigan resigned from her position as liquidator of Real Fires (NZ) Limited (in liquidation) on 25 June 2022, appointing Boris van Delden, Licensed Insolvency Practitioner of Auckland as her successor.

The liquidation of Real Fires Group Limited will continue as required, for the completion of the liquidation of Real Fires (NZ) Limited (in liquidation).

No preferential creditor claims have been received at the date of this report.
