#### 1 INTRODUCTION AND APPOINTMENT

Iain McLennan and Boris van Delden, Licensed Insolvency Practitioners of Auckland, were appointed jointly and severally as receivers of Tax Gnome Limited (In Receivership) ("the company") on 23 September 2020. The receivers were appointed under the powers contained within a General Security Agreement dated 2 September 2019 in favour of Agentro Limited.

Pursuant to section 24 of the Receiverships Act 1993 ("the Act"), the receivers report herewith on the progress of the receivership. This third report should be read in conjunction with the receivers' previous report(s).

A statement of Realisations and Distributions is **attached**.

#### 2 RESTRICTIONS

This report has been prepared in accordance with Section 24 of the Act. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

We reserve the right (but are under no obligation) to review and, if we consider necessary, revise this report in respect of any information existing at the date of this report which becomes known to us after that date.

#### 3 CONDUCT OF THE RECEIVERSHIP DURING THE PRECEDING SIX MONTHS

The Receivers have maintained the app functionality and assessed the software that has been developed.

From our assessment of the software, we understand that its development remains incomplete with further work required to increase its potential market audience and accessibility before it is able to be brought to market.

The Receivers sought new investment and interest in the purchase of the business through a number of agents and third parties. None was forthcoming of sufficient capital.

## Asset Realisations

- **Bank Account Closure** (Statement of Affairs: \$N/A)
  - The Receivers recovered \$315 from the closure of the company's bank accounts.
- **Pre-Receivership GST Refund** (Statement of Affairs: \$N/A)
  - The pre-receivership GST refunds of the company have been completed and filed by the Receivers. \$159 has been recovered from the refunds.

## 4 PROPOSALS FOR DISPOSAL OF RECEIVERSHIP PROPERTY

No party has shown an interest in acquiring the app/software for value. It is proposed that the software in its current state will be valued and transferred to the secured creditor in partial satisfaction of their General Security Agreement.

The Receivers estimate the receivership will be concluded within the next six months.


