Liquidators' Sixteenth Report For the period from 10 December 2014 to 9 June 2015

1 INTRODUCTION AND APPOINTMENT

Iain McLennan and Boris van Delden, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Twinaplate Limited ("the company") on 10 December 2007.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This sixteenth report should be read in conjunction with the liquidators' previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

Asset Realisations

2.1 Failed Sale and Purchase Agreement

(Statement of Affairs \$205,553)

The purchaser failed to settle the sale and purchase agreement within the required timeframe. The liquidators had no option but to cancel the agreement. The fixed assets were repossessed by a secured creditor who had a specific security on the assets.

4 INVESTIGATIONS

The liquidators have commenced their investigations into the books, records and affairs of the company. The liquidators are reviewing the outcome of a related Court hearing including the impact of the criminal findings against Mr John Ede in order to decide whether or not to make claim against a number of parties.
